

# OPENING KEYNOTE: DR. BILL DOHERTY, PH.D.

The Ethical Lives of Clients: Our Role as Therapists

#### About the Speaker

Dr. Bill Doherty, Ph.D. is a Professor in the Department of Family Social Science at the University of Minnesota where he directs the Minnesota Couples on the Brink Project, which developed "discernment counseling" for couples on the brink of divorce. Bill cofounded the nonprofit Braver Angels in 2016 to bring couple therapy skills to address



political polarization in the country. His most recent book is The Ethical Lives of Clients: Transcending Self-Interest in Psychotherapy, published by APA. Among Bill's awards is the Lifetime Achievement Award from the American Family Therapy Academy.

#### Option 1- The Power of Relationship Counseling: Treating People Together in an Age of Disconnection, Isolation, and Loss Dr. Nathan Hardy Ph.D., Associate Professor and MFT Program Director, Oklahoma State University Student Union, French Lounge Room 270

Although we may live through difficult times of relationship fragmentation and loss, we still yearn for connection, community, and civility. Relationship counseling has taught us the power of human bonds and the pathways of reconciliation. Explore the research, tools, and principles of relational healing.

Option 2- Ethics in Critical Incident Debriefing Nikkie Dunnigan, M.S. LPC Student Union, Sequoyah Room 280

When tragedy strikes, mental health professionals can provide necessary support to impacted individuals and institutions through critical incidence response. Explore professional counseling ethics related to this invaluable work.

#### Option 1- Using Expressive Arts to Help Clients Process Grief and Loss Dr. Lisa Beijan Ph.D., Assistant Professor, Oklahoma State University Student Union French Lounge Room 270

Using expressive arts as part of counseling allows clients to connect with their feelings and experiences more effectively than with talk therapy alone. This session will provide an overview of expressive arts in counseling and discuss specific expressive activities for addressing grief and loss.

# Option 2- Ethical Considerations of Working with LGBTQ+ Clients: Navigating Current Legislation

In the current political climate in Oklahoma, legislation is frequently targeting members of the LGBTQ+ community and their health care needs. Mental health professionals often struggle to navigate adherence to ethical and legal guidelines and creating safe and affirming spaces for clients. This breakout session will address implications of recent legislation for mental health professionals and identify ways to work with clients impacted by anti-queer policies more effectively.

## **BREAKOUT SESSION 3**

Option 1- Existential Therapeutic Approaches and Community Outreach for Grief and Loss Jonathan Ishoy, M.S. LPC, and Cheyenne Fisher, Grief and Loss Intern Oklahoma State University Student Union French Lounge Room 270

Providing grief and loss support to students, faculty, and staff on university/college campuses benefits from an integrative approach that incorporates both possible clinical referral and outreach. During times of bereavement existential approaches can assist in reorienting meaning making strategies for individuals and the campus community. In addition, establishing an outreach program can help support the campus community in coming together and providing resources.

Option 2- Bringing It Up, Breaking It Down: Ethical Considerations for Acknowledging and Discussing Nuances of Race and Identity. Mindy Windholz LPC-S, Staff Counselor, University of Oklahoma Student Union, Sequoyah Room 280

By incorporating the ACA code of ethics, the presentation will center around awareness of privilege and encouragement of deeper consideration of how historical trauma can impact a therapeutic relationship, especially if the provider is white and the client is BIPOC. I will touch briefly on somatic theory from the works of Resmaa Menaken and provide suggestions on how to gently approach the topic of race with clients. It will be noted that race does not equal a monolithic experience but will bring attention to how historical trauma can manifest in the body and how this may affect the therapeutic alliance. I will also provide space for discussion and a reading list for any attendee interested in continued education.
